

#### **Police Enforcement Project**

Late last year we surveyed CVRA members about police enforcement problems and issues occurring in Capitola neighborhoods. We recently compiled the results and are making plans to approach Police Chief Card to review them. All responses will be kept anonymous. At this meeting we also want to open the lines of communication, plus discuss proactive solutions. We'll let you know how it goes.

### **Traffic and Parking Commission**

The Traffic and Parking Commission is preparing an Interim Report to the City Council which will recommend that the City substantially expand parking Village the surrounding for Capitola and neighborhoods by constructing a parking structure on the existing upper Pacific Cove parking lot and by a modest consolidation of coaches in the lower Pacific Cove Mobile Home Park. These two projects could create as many as 438 additional new parking spaces. One of the bigger challenges is funding which is being explored at press time.

The City is actively exploring converting the current style parking meters in some portions of the Village to a new "Pay Station" system, similar to the system just installed in Santa Cruz's parking structures. They are awaiting bids from manufacturers. The exact areas and numbers of meters to be converted are unknown at this time. The City estimates this new system will generate 20% more revenue with no increase in parking rates.

## A Very Brief History of the CVRA Neighborhood Riverview Terrace

The earliest known inhabitants of Riverview Terrace were Uypi Indians, who were removed to Mission Santa Cruz in 1769.

In the early 1870s, a beet sugar mill was moved from Alvarado with promises that better management and

better soil would make fortunes for the newly formed California Beet Sugar Company. Picture the Nob Hill building and parking lots as beet fields, an active beet mill atop Riverview Terrace, with some 200 employees (mostly Chinese). However, the company went bankrupt after a few years, and the beet operation in Capitola was abandoned, with the 10 acres of land being repurchased by Frederick Hihn for \$100.




Capitola Museum Director Carolyn Swift showing the South border of the Beet Sugar operation at the corner of Oak and Beverly in Riverview Terrace.

Henry Rispin planned a subdivision called "Riverview Tract" in the middle 1920s. After Rispin's financial difficulties, the subdivision was pursued again, with the area to be known as "River View Park". Finally, the name "Riverview Terrace" appeared in 1931. Apparently, the start of the Great Depression wasn't a great time for buying summer cottages, although the roads we're familiar with were there.
