

General Plan Update Community Workshop #4 and Pacific Cove/City Hall Special Study Area

On Saturday, May 12, 2012, a community workshop was held to allow for public input on the above two subjects. Attendance was only about 15 members of the general public, plus members of the GPAC, city staff and some of the consultants hired to assist with preparing the General Plan. We broke into three groups to discuss how we'd like to see the Pacific Cove site utilized and what to do about the fact that City Hall and the police department are located in a 100 year flood zone. There is some grant money available to mitigate local hazards.

The general consensus was that more parking was the chief concern. More parking is needed in the village to hopefully reduce the traffic congestion in the village, reduce the amount of tourist parking in the neighborhoods and allow any expansion for businesses because the Coastal Commission will not allow any expansion without more public parking.

As for the lower Pacific Cove site, the general consensus seemed to be to use possibly all or part of it as temporary parking while the funding for the parking structure is secured and the parking structure constructed. Also most felt that once the parking structure is completed, the Pacific Cove site should be devoted to recreational use, possibly day lighting the Noble Gulch Creek or part of it.

Most participants seemed to feel that moving City Hall was not a priority. One suggestion was to add a third floor to get the offices out of the flood plain and possibly using the first floor for retail space.

Riverview Terrace Traffic and Safety

Terrace residents petitioned the Council and are now meeting with Chief Escalante to explore ways to improve safety for pedestrians, drivers and pets in their neighborhood. Riverview Terrace has narrow streets and many cars parked on the street. Proposed measures are a 15 MPH zone throughout the Terrace, additional stop signs on Beverley and increased enforcement of traffic laws including speed, full stops, cars parked in driveways blocking sidewalks and long term parking of oversized vehicles such as boats, construction trailers, etc. The Police Dept. is using its radar trailer to accumulate data on vehicle counts and speeds.

Another neighborhood meeting is scheduled before a recommendation comes back to the Council.

Traffic and Parking Commission

With the pending closure of Pacific Cove Mobile Home Park in late July there is renewed public discussion about developing additional parking supplies and other uses on that 3.5 acres. The land was purchased in the early 1980s expressly to provide parking for Capitola Village. Parking meters were installed to pay for the purchase, and millions of dollars in meter revenues have gone into the City treasury. But the best parking solutions are expensive in a time of tight city budgets. Furthermore, passionate voices want to devote some of this land to uses other than parking cars. For CVRA members it is important to note that 300 or more NEW parking spaces in Pacific Cove should give us tremendous relief from the Village parking burden that has been pushed into our neighborhoods. Perhaps the answer will be a sequence of uses including temporary surface parking, a permanent parking structure and finally a change to open space and recreational uses. The debate continues.



Capitola and the Depot co-evolved. The depot brought the outside world to Capitola, both physically and informatively. The telegraph at the depot let one person at a time send text about the size of tweets down the line to be repeated until arriving at a Western Union office where the text was transcribed and hand delivered. Another round of promotion happened in the early 1900s when the lovely new depot was built (the building to the right of the engine).

Southern Pacific stopped passenger service in 1950, and the depot was abandoned in 1956. It was sold for \$1 and eventually turned by 90 degrees to become the Inn at Depot Hill. (Thanks to Carolyn Swift and the Capitola Museum for vintage photo and help with content.)



History of Capitola Neighborhoods: Depot Hill

The pattern of streets we recognize in Depot Hill today was defined in subdivisions starting in the 1880s, minus the loss of a road or two to the erosion of the cliff. The Santa Cruz Railroad stop was on the Santa Cruz side of Soquel Creek until the railroad was rebuilt as standard gauge in 1883, and at that time, the existing small depot was moved to the Watsonville side (just visible to the left of the steam engine in the top picture right). Money was in the air, and a world-class hotel was building, and customers no longer wanted to get off the train on the wrong side of the Creek and have to walk to the beach and across the sand to get to the hot side of town.
